TEACHING EXPERIENCE

Texas A&M University- Corpus Christi (2014-2020, Assistant Professor, 2020-Present, Associate Professor)

Assistant Professor and Associate Professor:

- Communication & Conflict Management (COMM 5390)
 - This course focuses on the incompatibilities or perceptions of opposition to goals, aims, and values that occur between two or more interdependent parties. Our concentration is on how communication creates, enflames, and mitigates conflict. This course will include instruction on the construct of conflict, theories of conflict, and conflict in various communication contexts.
- Communication & Uncertainty (COMM 5390)
 - This course focuses on the uncertainty and the role of communication in creating, managing, and reducing uncertainty. This course includes instruction on the construct of uncertainty, theories of uncertainty, and uncertainty in various contexts.
- Small Group Decision Making (COMM 5314)
 - This course focuses on the ways in which groups develop tasks, analyze problems, develop and evaluate solutions, and implement solutions through communication.
- Seminar in Persuasion Theory (COMM 5311)
 - This course includes instruction on various theories, lines of research, and the role that persuasion and social influence play in a variety of contexts.
- Communicating Leadership (COMM 5308)

- This course concentrates on the process of influence that takes place through communication to achieve goals or to produce change from a collective of people. This course will include instruction on the various approaches to leadership, processes of leadership, and the role that leadership plays in a variety of contexts. This course is intended as an overview of contemporary theory and research in leadership.
- Teamwork and Leadership (COMM 5308)
 - This course focuses on the study of small groups. This course includes instruction on various theories of small group communication, research about leader and group member behaviors/roles, and the various outcomes associated with small group communication.
- Communication and Organizations (COMM 5307)
 - This course introduces graduate students to contemporary theory and research in organizational communication with special emphasis placed upon how organizational members help construct and alter their workplaces.
- Instructional Communication (COMM 5306)
 - This course focuses on the study of communication in teaching/training environments. This course includes instruction on various theories of instructional communication, research about teacher and student behaviors, and the various pedagogical implications of the research about instructional communication.
- Research Methods (COMM 5303)
 - This course functions to increase students' knowledge of the research process used in the communication Studies discipline. Specifically, the course will allow students the opportunity to learn the goals of communication research and scrutinize various techniques for creating academic research and assessing academic knowledge, and develop their own communication research proposal.
- Seminar in Communication Theory (COMM 5302)
 - This course provides an overview of the development and application of sets of systematic ideas about the process of communication. Special focus will be placed on application of theory in a variety of contexts including cognition/intrapersonal communication, interpersonal communication, family communication, intercultural communication, instructional communication, organizational communication, and media/mass communication.
- Introduction to Communication Scholarship (COMM 5301)

- This course familiarizes students with the communication discipline. This course is intended as a foundational course emphasizing scholarly insight and skills helpful for academic and professional success.
- Senior Seminar in Communication (COMM 4380)
 - This course serves as the capstone experience to students emphasizing communication studies in their degree program with special emphasis placed on preparing students to apply their communication skillsets beyond the academic setting.
- Research Methods (COMM 4325)
 - The purpose of this course is to increase students' knowledge of the research process used in the Communication Studies discipline. Specifically, the course will allow students the opportunity to learn the goals of communication research and scrutinize various techniques for creating academic research and assessing academic knowledge.
- Organizational Communication (COMM 4350)
 - This course focuses on the complex and continuous process through which organizational members create, maintain, and change their organizations. This course includes instruction on the role that communication plays in constituting and altering organizations with special attention placed upon interaction of organizational members with their organizational environment. This course is an overview of contemporary theory and research in organizational communication.
- Leadership (COMM 3350)
 - This course focuses on the communication of influence that takes place to achieve goals or encourage change. Specific attention will be devoted to a variety of approaches and theories of leadership, characteristics of leaders and followers, and general knowledge of leadership as an academic area of study.
- Persuasion (COMM 3330)
 - This course focuses on the art and science of persuasive communication and includes instruction on various theories, lines of research, and the role that persuasion and social influence play in a variety of contexts that include organizations, classrooms, and everyday interaction.
- Communication Theory (COMM 3310)
 - This course provides students an overview of the development and application of sets of systematic ideas about the process of communication with special focus placed on application of theory in a variety of contexts such as interpersonal relationships, small groups, persuasion, mass communication, instruction, and organizations.

- Introduction to Communication (COMM 1370)
 - This course focuses on familiarizing students to the research, principles, and theories of the Communication discipline and is intended to provide insight into a breadth of topics about the Communication discipline that are examined with greater depth in the Communication curriculum.
- Foundations of Communication (COMM 1311)
 - This course focuses on familiarizing students to the research, principles, and theories of the Communication discipline. This particular course is intended to provide insight into a breadth of topics about the Communication discipline and will focus attention on sharpening students' communication abilities in everyday interaction.

West Virginia University (2011-2014, Graduate Teaching Assistant)

Instructor:

- Public Communication (COMM 104)
 - This course provides students an understanding of one-to-many communication with special attention placed on the role of communication traits, critical thinking, problem solving, and listening in the public communication context.
- Introduction to Mass Media (COMM 105)
 - Students in this course focus on the role of media in the communication process. Media's impact on both how and what is communicated is examined through both discussion and relevant theories.
- Business and Professional Communication (COMM 303, online)
 - Students in this course learn to build their professional identities through assignments designed to provide them insight into communicating within business environments.
- Communication in Organizations/Institutions (COMM 306)
 - The focus of this course is to familiarize students with foundational theories of organizational communication and communication processes that comprise organizations.
- Nonverbal Communication in Human Interaction (COMM 308)
 - The focus of this course is on familiarizing students with the role of nonverbal communication in various contexts. The role of vocalics, proxemics, haptics, oculosics are given special attention about how they affect communication processes.
- Advanced Organizational Communication (COMM 406)

- The focus of the course is to discuss the various theoretical perspectives and types of coworker relationships in the organization. The role of supervisor-subordinate, peer coworker, workplace friendships, and workplace romances are given special attention and how they affect organizational processes.
- Organizational Culture (COMM 426, in-person and online)
 - The focus of this course is to provide students an understanding of the role communication plays in creating and reinforcing organizational cultures. Attention is focused on how values, artifacts, and assumptions guide the behavior of organizational members.

Course Administrator:

- Communication in Organizations/Institutions (COMM 306, Spring 2013)
 - This three-hour course consists of 2-3 sections per semester. Enrollment ranges from 175-250 students per section. Course administrators are responsible for managing various sections of the course. Specific responsibilities include creating syllabi, schedules, policies, and tests.
